83. **Highways Working Group Report**

- 83.1 Mr. Jim Rudd had given a precis of his interest in joining this group, he will be a valuable addition to team - NF proposed, LB seconded, all agreed to the co-option
- 83.2 Since last meeting there had not been a formal meeting. NF has been in touch with Gary Overland to do complete items promised - two remain: - a) Market Lane still needs to be resurfaced; b) slow signs, stop signs, have been painted, apart from the junction coming down Mill Road to the main road - the most important junction in the village.
- 83.3 Audley End there are issues at the level crossing, however British Rail are not allowing Highways to address this.
- 83.4 Flooding in Shimpling across from the treatment centre, it is unclear where the drain in road goes to, however it seems possible that it has collapsed. There is still flooding on Mill Lane near to CS.
- 83.5 Hall Lane in Shimpling the bin lorry is unable to pass landowner has trimmed the hedging back a little, Network UK have trimmed it a little more - the lorries are now able to pass through to empty the bins safely
